This Exemplification will be limited to 75 Candidates not including Priests. Each Assembly is encouraged to bring a priest to this degree. ***The Exemplification will be held in Honor of: Rev. Msgr. Eugene (Geno) Sylva, S.T.D.***

The size of the Exemplification is being controlled due to the limitations of the facilities. We are asking the Assemblies to turn in their Form 4's early. 3. Dinner reservation forms will be distributed on-line and at the September meeting. The cutoff date for dinner reservations is November 4, 2019. *This means that ALL the RESERVATIONS MUST be in the hands of the Chairman John LeClercq on that date, not postmarked that date.* All dinner reservation forms must be accompanied by an Assembly check.

All Dinner Reservation (Assembly) Checks should be made Payable To: "Paul Pinkman, Master".

Please make separate checks for all items submitted. **DO NOT** combine Candidate fees, Dinner Reservations, and Ad Journal money, etc.

Please advise ALL candidates to eat a good breakfast since they will not have the opportunity to eat after check-in.

Please advise the Master at least 2 weeks before the Degree of all candidates who *cannot stand* during the degree so that seating arrangements can be made.
